

1.	Skimmed Milk Powder manufactured not before May, 2017 & as per BIS certified.	150 MT
2.	<b><u>On Line Rates/Offer</u></b> : Your <b>online rates / offer</b> indicating the quantity of Skimmed Milk Powder for supply to this office, price payable per MT <b>FOR DMS Godown</b> (including taxes, transportation, insurance, loading/unloading etc) alongwith delivery schedule should be uploaded well before the closing date. <b>Manual offer shall not be accepted.</b>	
3.	<b><u>Offer Validity</u></b> : Your offer / rate should be valid upto <u>15.10.2017</u> .	
4.	<b><u>Product Quality</u></b> : Skimmed Milk Powder should be manufactured not before May, 2017 and as per BIS Certified.	
5.	<b><u>Quality Inspection</u></b> : Pre delivery may be carried out by DMS Quality Control Team before supply of consignment as per DMS requirement. However, final inspection shall be carried out at Delhi Milk Scheme and shall be considered as final.	
6.	<b><u>Quantity</u></b> : DMS shall have the option to increase the above quantity upto 50% at the same rates, terms & conditions.	
7.	<b><u>Delivery Period</u></b> : Delhi Milk Scheme being Central Govt. Organization and is supplying milk & milk products to the Parliament of India, Hospitals, Defence Installation, institutions etc. Hence Delivery Period is the essence of the contract / purchase order which must to be adhered to.	
8.	<b><u>Tender Opening</u></b> : Tender Enquiry containing terms & conditions can be downloaded from Central Public Procurement – Portal website i.e. <b>eprocure.gov.in/eprocure/app</b> from <b>26.09.2017 to 06.10.2017</b> (upto 14:00 PM).
