- 4. Quality Inspection :** Pre delivery inspection shall be carried out by DMS Quality Control Team before supply. Final inspection shall be carried out at Delhi Milk Scheme.
- 5. Quantity :** DMS shall have the option to increase the above quantity upto 50% at the same rates, terms & conditions
- 6. Delivery Period :** Delhi Milk Scheme being Central Govt. Organization and is supplying milk & milk products to the Parliament of India, Hospitals, Defence Installation, institutions etc. Hence Delivery Period is the essence of the contract / purchase order which must to be adhered to.
