

Delhi Milk Scheme is Central Government Organization under Ministry of Agriculture engaged in supplying high quality milk and milk products to the citizens of National Capital and intends to purchase the following material from State Dairy Federations only.

1.	White Butter manufactured not before October, 2016 & as per BIS Standards	300 MT
2.	<b><u>On Line Rates/Offer</u></b> : Your <b>online rates / offer</b> indicating the quantity of White Butter offered for supply to this office, price payable per MT <b>FOR DMS Godown</b> (including taxes, transportation, insurance, loading/unloading etc) along with delivery schedule should be uploaded well before the closing date. <b>Manual offer shall not be accepted.</b>	
3.	<b><u>Offer Validity</u></b> : Your offer / rate should be valid upto <b>28 February, 2017.</b>	
4.	<b><u>Product Quality</u></b> : White Butter should be manufactured as per BIS Standards and not before October, 2016.	
5.	<b><u>Quality Inspection</u></b> : Pre delivery inspection shall be carried out by DMS Quality Control Team before supply of consignment as per requirement of DMS. However, final inspection shall be carried out at Delhi Milk Scheme.	
6.	<b><u>Quantity</u></b> : DMS shall have the option to increase the above quantity upto 50% at the same rates, terms & conditions	
7.	<b><u>Delivery Period</u></b> : Delhi Milk Scheme being Central Govt. Organization and is supplying milk & milk products to the Parliament of India, Hospitals, Defence Installation, institutions etc. Hence Delivery Period is the essence of the contract / purchase order which must to be adhered to.	
8.	<b><u>Tender Opening</u></b> : Tender Enquiry containing terms & conditions can be downloaded from Central Public Procurement – Portal website i.e. <b><u>eprocure.gov.in/eprocure/app</u></b> from <b>15.02.2017</b> to <b>21.01.2017</b> (upto 10.00 AM). Your online tender offer alongwith terms & condition shall be accepted upto 10:00 AM on 21.02.2017 and will be opened thereafter at 10:00 AM on 22.02.2017. No manual rate offer shall be accepted.
