

3. Rates offer must be firm and final. Rates offered of the goods for delivering the same in DMS premises inclusive of Excise Duty, Sales Tax, Packing Forwarding, Transportation and Octroi etc.
4. The offer must accompany with EMD of Rs.10,000/- in the form of DD/FDR in favour of General Manager, Delhi Milk Scheme, which will be returned after completion / supply of the ordered quantity. Micro & Small Enterprises (MSEs) are exempted from EMD.
5. General Manager, DMS reserve the right to cancel the supply order without any separate notice on expiry of the delivery period in the event of non supply of goods within the delivery period and or the quality of goods supplied having been found not as per specification leading to rejection on inspection of the goods supplied by stipulating the option on the time of issual of the final acceptnace of order and Governement is no way to responsible to compensata the supplier (s) on account of such cancellation of the supply order.
